3. The purposes of processing personal data

Personal data is used for the purpose you have indicated in the survey. The data is either for contacting you for follow-up interview, or, sending you more information about the project and upcoming events.

The Ecolabnet survey will be conducted between 27.9.2019-1.11.2019, but we reserve the possibility to extend the research period. The data will be downloaded and erased from SurveyMonkey immediately after survey has been ended. The entire data will be stored in the secured data network managed by VAMK University of applied sciences due to the financial terms of the project.





This privacy notice has been published on the website of the Ecolabnet-project, and the electronic survey includes a direct link to this information.

6. Profiling and automated decision-making

In this study, the controllers and project partners will not use your personal data in automated decision making or profiling.

7. Protection of personal data

The registry is managed in accordance with the data security and privacy guidelines of VAMK University of applied sciences. Personal data used in the study will be protected by means of

- username and password (electronic data)
- access control in physical facilities (physical data)

9. Recipients of personal data

All the personal data collected from you will be processed in accordance with the General Data Protection Regulation (GDPR). Controllers do not transfer your personal data outside the EU/EEA.

- the online query service provider (SurveyMonkey)

10. Prevention of identifiablty

Contact information will be used only for purpose indicated by the respondent in the survey. The data will be anonymized for analyzing and reporting.

11. The processing of personal data after the study

The duration of the Ecolabnet project is until 30.6.2021. After the end of the project, the personal data file will be archived in its entirety for a maximum of 10 years based on the regulations in the Interreg financial agreement. The data is stored on a secured network drives of the project partners. Written documents are stored in project folders under access control.

13. Implementation of personal rights
